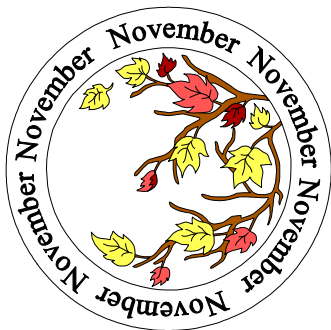

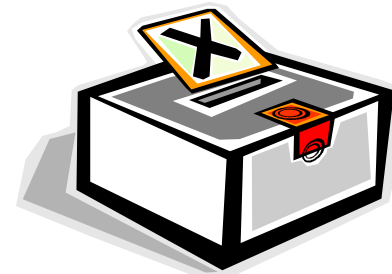

# ELECTION NOMINATIONS FOR DECEMBER 5, 2009 (CONTINUED)

### Eligible to Vote

To be eligible to vote in any election for any office, a member must have been for at least one year prior to such election a member of the Local in good standing and, at the time of such election, classified as a Journeyman. (Local 50 Constitution, Article X, Section 2, Paragraph j)

A member must cast their ballot in any election in person; that is, there shall be no absentee balloting. (Local 50 Constitution, Article X, Section 2, paragraph k)

Any member who enters business legitimately for himself, or who holds a financial interest in any business directly connected with the plumbing and pipe fitting industry, shall not have the right to voice or vote or take any part in the official affairs of the Union until one (1) year after the member has terminated his business or financial interest. (U.A. Constitution, Section 161)

Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of election shall not be eligible to vote in any Local Union Election. (U.A. Constitution, Section 124)

Please keep in mind this mailing is going to the entire Local 50 Membership, those who are eligible to vote and also those who are not.

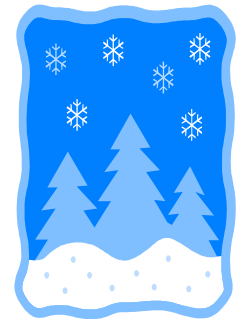

Dispatch will be delayed till the next working day. If you have doubt whether we are open, give us a call before coming to the Hall.

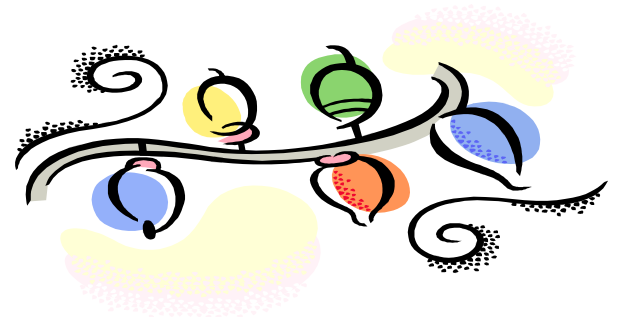


## **R**ETIREES ALUMNI MEETING

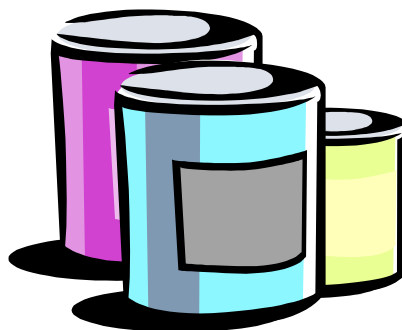
## **H**EALTH SCREENING
