The Hall will close at 12 noon on Christmas Eve.

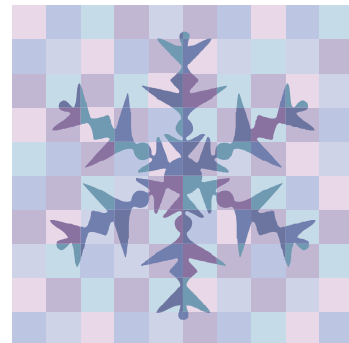
The Nurse's Office will be closed December 24<sup>th</sup> - January 3<sup>rd</sup> for vacation.
